- \* Agree the City of Park Rapids may remove damaged sculpture in the absence of prompt and safe on-site repair
- \* Agree the city is not responsible for any repair. (It is suggested but not required that sculptors have individual insurance coverage.)
- \* Agree to be responsible for the delivery and pickup on the designated dates and will receive a \$350 honorarium during installation and \$150 during sculpture removal.
- \* Attest that work is of sound design, is free-standing and is ready to be placed in an outdoor public space near the Heartland Trail and Fish Hook River in Red Bridge Park
- \* Grant permission to use photographs of selected work(s) for promotional purposes (in news media, on websites, etc.)

The Parties (City and artist) shall and hereby agree to defend, indemnify and hold harmless each other against any liability that arises out of the other party's negligent or willful behavior.
